For the proposed project, FOB value of exports for the 5 years period is projected as Rs. 6105.00 Lakh, with outgo of foreign exchange as Rs. 2596.67 Lakh, resulting NFE of Rs. 3508.33 Lakh (135.11%), from manufacturing activity. The Developer (M/s. DGDC Ltd.) vide letter dated 13.02.2020 has earmarked the Unit No. 134 on Plot No. 256 with area admeasuring 1000 Sq. Ft. for the proposed project in the SEZ and also confirm the space. On scrutiny of the application form submitted by the applicant, it appears that the total investment is amounting to Rs. 100.00 Lakhs, which will be arranged by Capital and Internal Sources.
