However, as per APRs for the financial year 2014-15 to 2018-19 it appears that unit's foreign exchange realization is pending as 12117.92 Lakh as on 31.03.2019.

A Show Cause Notice F. No. SSEZ/G-16/336/2015-16/1270-1273, dated 27.10.2015 was issued to the unit for failure to realize and repatriate the value of goods amounting to Rs.10328.38 Lakh as on 31.03.2014.

It appears that the unit has further failed to realize the value of goods exported amounting to Rs.1789.54 Lakh (Rs.12117.92 Lakh minus 10328.38 Lakh for which SCN dated 27.10.2015 was issued.

As per Rule 71 of the Special Economic Zone Rules, 2006, export value of goods, software and services may be realized and repatriated as per instructions of the Reserve Bank of India issued from time to time".

As per Reserve Bank of India's instruction/circulars issued from time to time, the units located in SEZs shall realize and repatriate full value of goods/software/services to India within a period of <u>nine months</u> from the date of export. Any extension of time beyond above stipulated period may be granted by Reserve Bank of India on case to case basis".

Whereas, as per the above circular of Reserve Bank of India, it appears that the unit has failed to realize and repatriate the value of goods amounting to Rs.12117.92 Lakh to India within a period of nine months from the date of export nor produced any documentary evidence showing extension of time beyond the stipulated period of twelve months granted by Reserve Bank of India as on 31.03.2019.

Whereas, the non-realized and repatriated amount needs to be treated as non-exports and as such their NFE status as reported by the unit in their APR automatically changes into Rs.1569.39 Lakh(Rs.1789.54 Lakh - Rs.220.15 Lakh).

As per the provision of the Rule 54 of the SEZ Rules, 2006 and the Letter of Approval, if a unit in SEZ has not achieved Net Foreign Exchange or failed to abide by any of the terms and conditions of the letter of approval or Bond cut LUT without prejudice to the action that may be taken under any other law for the time being in force, the said unit shall be liable for penal action under the provisions of Foreign Trade (Development & Regulation) Act, 1992 and the rules made there-under.

Hence, the same has been placed before the Approval Committee for consideration and suitable decision.

(4) Request made by M/s. D. Jewels, Plot No. 183, Surat SEZ, for renewal of Letter of Approval.

The unit have applied vide their letter dated 10.07.2020 for renewal of LOA in the prescribed Proforma. The Approval Committee in its 83rd meeting held on 24.07.2019 has extended the validity of Letter of Approval for 2nd Block from 25.02.2017 to 25.07.2019 or till the date of clearance/export of all stocks (raw materials/finished goods) lying in the unit, whichever occurs earlier. The unit could not cleared/exported of all stock till 25.7.2020 due to Corona Pandemic as intimated vide their email dated 24.06.2020.

The unit has submitted closing summary of raw materials as on 31.03.2020 is attached herewith as per Annexure-A.

In view of the above, the matter is put up before the Approval Committee for consideration and suitable decision.

(5) Request made by M/s. Mital Jewels, Unit No. 17-N on Plot No. 222-A, Surat SEZ for inclusion of additional Plot no. 294-A in their existing LOA.

M/s. Mital Jewels, Unit No.17-N on Plot No.222-A, Surat SEZ vide letter dated 20.11.2020 and online request ID No.422000223783 has requested for inclusion of plot no. 294-A in their existing LOA dated 30.01.2018 as amended.
