(12) Request made by M/s Jewelen Pvt. Ltd Unit No. 88, Plot No. 302, Surat SEZ, for amendment in HSN code in their existing LOA.

M/s Jewelen Pvt. Ltd Unit No. 88, Plot No. 302, Surat SEZ vide their letter dated 03.06.2022, for issue on their LOA vide the above referred letter the unit has requested for amendment in HSN code in their existing LOA.

As per letter dated 28.01.2021 the unit has submitted HSN code for Moissanite Diamond 71049000 but while issuance of Letter of approval F.No. SSEZ/II/0212020-21 dated 15.02.2021 the HSN code for Moissanite Diamond has been inadvertently written as 71131130.

The unit vide letter dated 03.06.2022 has requested for correction in HSN code of Moissanite diamond in LOA dated 15.02.2021 from 71131130 to 71049900. As per new Custom Tariff dated 01.05.2022 the HSN code for Moissanite diamond is 71049900.

Further the unit has also requested to amend ITC HSN code of Watch Jewellery from 91149030 to 71179090.

Hence, the matter is put up before the Approval Committee for suitable decision.
