TRADE NOTICE

संबंधित एसईजेड इकाइयों का ध्यान Surat SEZ में चल रहे ICEGATE कार्यान्वयन की ओर आकर्षित किया जाता है। / Kind attention of concerned SEZ units is drawn to Public Notice No.01/2024-25 dated 25.06.2024 regarding Rollout of Indian Customs EDI System – (ICEGATE for Imports and Exports at SEZ).

2. In this regard, kind attention of SEZ units in Surat SEZ is drawn to Rule 22(iv)(b) of SEZ Rules,2006

"the value of the Bond-cum-Legal Undertaking shall be equal to the amount of effective duties leviable on import or procurement 73[of goods and services] from the Domestic Tariff Area of the projected requirement of capital goods, raw materials, spares, consumables, intermediates, components, parts, packing materials 74[and services] for three months as applicable but which will not be levied on account of admission of such goods into the Unit or the amount of effective duties leviable on import or procurement 75[of goods and services] from Domestic Tariff Area of the projected requirements of goods for the authorized operation by the developer but will not be levied on account of admission of such goods into the Special Economic Zone;"

3. In view of the above, SEZ units are advised to ensure that Bond amount in their BCLUT (Bond-cum-Legal Undertaking) is sufficient to cover all the duties/taxes/cess as leviable. In case the value of Bond-cum-Legal Undertaking executed falls short, unit are advised to submit additional Bond-cum-Legal Undertaking.


4. Further, SEZ units are yet to register their authorized dealer code (AD code) on the ICEGATE portal are directed to register the same in an earliest manner. The option to apply for AD code registration is available on ICEGATE dashboard which is to submitted by the unit and is to be accepted by the officer. Advisory for AD Code registration on ICEGATE 2.0 is enclosed herewith for ready-reference.

This is a one-time requirement. However, if IEC has registered AD Code at any EDI location previously, the same can be used at SEZ locations for filing the document.
