Brief Note

For the proposed project, FOB value of exports for the 5 years period is projected as Rs. 20468.00 Lakh, with outgo of foreign exchange as Rs. 18694.00 Lakh, resulting NFE of Rs. 1774.00 Lakh (9.49%), from manufacturing activity. On scrutiny of the application form submitted by the applicant, it appears that the total investment is amounting to Rs. 190.00 Lakh, which will be arranged by Own Fund.
